Major Challenge Facing TADE Group's Federal Government Clients

**LACK OF ACCOUNTABILITY, TRANSPARENCY,
AND LEARNING IN PROGRAM REPORTED DATA**

TADE GROUP CASE STUDY: A USG FEDERAL AGENCY GLOBAL HEALTH PROGRAM

This USG Federal Program supports health ministries in over 50 countries to provide critical prevention and treatment services to about 80% of the affected population. In Africa treatment services are provided through Implementing Partners (IPs) who are usually USG grantee and contractor organizations in respective countries. Discrepancies in reported data and alleged mismanagement and misappropriation of funding related to the provision of services in certain countries prompted Client to question the fidelity and determine the accuracy of reported data by health ministries and IPs.



Problem was:

- Discrepancies in data reported by Health Ministries in respective countries and by USG Implementing Partners.
- Alleged mismanagement and misappropriation of funding related to the provision of services.
- Lack of standardized systems and processes for transparency and accountability.



Solved by:

- Creating a uniquely tailored model to for comprehensive assessment at 8000 supported sites in respective countries.
- Geospatially mapping each site to authenticate its existence.
- Locally hiring, training, deploying data enumerators to sites Collecting facility-level source data.



Results were:

- Mapped sites provided **transparency** on existing (85%) and never existed (15%) sites yet 'funded' for 10 years.
- Identified underlying reporting systems of inaccuracies identified for **accountability**.
- The model's analytics provided 100% prescriptive modeling for **learning** to support future programming decisions
